Special news bulletin

1. If you wish to receive the special news bulletin that is occasionally sent out to registered chaplaincy members, please enter your e-mail address in the space provided.
2. For the sign-up to our special bulletins we use what is known as a double opt-in procedure. This means that, we will send an e-mail to the e-mail asking you to confirm that you wish to receive this occasional special news bulletin. If you do not confirm within 24 hours your details will be blocked. After one month they will then be automatically deleted. In addition to your e-mail address, the IP addresses from sign-up and confirmation, and the date and time you signed up and confirmed will also be stored, prove your subscription registration and to be able to trace the registration back to the source in the event of any suspected misuse of your personal data.
3. After we have received your confirmation, your e-mail address will be stored for the purpose of sending you the news bulletin. The legal basis for storing these data is Article 6 paragraph 1 page 1 letter a of the DS-GVO (Datenschutz-Grundverordnung = General Data Protection Regulation) and Section 6 paragraph 1 letter b of the KDG (Kirchliches Datenschutzgesetz = German Church Data Protection Act).
4. You may cancel your subscription and revoke your consent to receive our special news bulletin at any time. To do this, simply click on the link contained in any news bulletin e-mail that you receive.
5. Once you cancel your subscription, the data stored in regard to the bulletin sign-up or in regard to the cancellation will immediately be placed in restricted storage and held for a limited period of time to serve as evidence that the subscription has been cancelled. This data will then be deleted once the legally prescribed period for the storage of such data has expired.
